## **ORDER**

Government as per the G.O. read as 1 st paper above transferred land equivalent to its share to KABCO formed under the Department of Agriculture. As per G.O. read as 2<sup>nd</sup> paper above Administrative sanction was accorded for the construction of an Integrated IT enabled Headquarters Building for the Departments of Agriculture and Soil Survey and Soil Conservation and allied agencies, which are not having their own buildings at Thiruvananthapuram.

- 2) The requirement of various departments/agencies to be housed by the building were collected and harmonized through several Technical Level Meetings conducted by the State Agriculture Engineer and Director(Infrastructure), KABCO and a draft physical design/layout plan was prepared and examined in detail. It was found satisfactory and meeting the requirements.
- 3) The first meeting of the High Level Committee held on 08/01/2024, has decided to take up the proposed Exhibition Centre of KABCO and related land developments with unified parking and other common facilities without affecting the present institutions therein, as these facilities will be co-usable for all establishments.
- 4) The draft layout and master plan (Annexe) were scrutinized in the meeting of High Level Committee held on 08.01.2024 in detail and approved the following estimate for the same:

- 5) Among these, Integrated Office Complex is already administratively approved for execution from Government funds. The Exhibition Centre is proposed to be financed by a suitable low interest commercial loan availed by KABCO to be paid back entirely from the revenue from the exhibition centre and Part (3) external development is to be consolidated later, after (1) & (2). KABCO shall execute the same, subject to its Board approval. Contracting for executing the integrated master plan connecting all three parts with common facilities is to be arranged together, i.e., (1), (2), & (3) together. The same is hereby approved.
- 6) Government approves KABCO to engage an eligible competent accredited agency as per latest Government Orders in force read as 4<sup>th</sup>, 5<sup>th</sup> & 6<sup>th</sup> paper above for the same. The construction of Exhibition Centre (Ex.C.) and Integrated Agri Complex (IAC) may be accordingly awarded adhering to the guidelines issued as per GO read as 4<sup>th</sup> paper above and payments governed by such terms and conditions permitted in force.
  - 7) The bills for the respective constructions will be settled as follows:
    - (a) MD, KABCO for Part (1), and
- (b) Part (2) by the Departments of Agriculture and Farmers Welfare and Soil Survey and Soil Conservation and other participating agencies in ratios/actual value to be approved by the High Level Committee. Order on part 3 financing will be issued later upon the advice of High Level Committee.
- 8) Any deviation exceeding Rs.10 lakh on the execution side due to contractors will be effected only with the prior approval of the High Level

Committee and above 10% of total estimation with the prior approval of the Government.

9) High Level Committee will monitor the project progress with Agricultural Production Commissioner and MD, KABCO, Directors of Agriculture and Soil Survey and Soil Conservation, preferring quarterly progress reports to Government.
